This accessibility statement applies to www.loreto.ac.uk. This website is run by Loreto Sixth Form College and maintained by Carbon Creative. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- zoom in up to 300% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader

Technical information about this website's accessibility

Loreto Sixth Form College is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

Compliance status

This website is partially compliant with the <u>Web Content Accessibility Guidelines version 2.1</u> AA standard, due to the non-compliances listed below.

Non-compliance with the accessibility regulations

- Some images do not have a text alternative, so people using a screen reader cannot access the information. This fails WCAG 2.1 success criterion 1.1.1 (Non-Text Content).
- Background and foreground colours do not have a sufficient contrast ratio. This fails WCAG 2.1 success criteria 1.4.3 and 1.4.6 (Contrast).
- Some headings are not in sequentially descending order. This fails WCAG 2.1 success criterion 1.3.2 (Meaningful Sequence).

Content that's not within the scope of the accessibility regulations

The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services: <u>Accessibility Regulations for PDFs</u>

Some of our PDFs are essential to providing our services, such as our prospectuses. We plan to either ensure these are accessible or replace them with accessible HTML pages by August 2025.

Any new PDFs or Word documents we publish will meet accessibility standards.

We do not plan to add captions to live video streams because live video is exempt from meeting the accessibility regulations: <u>Accessibility Regulations for live video streams</u>

What we're doing to improve accessibility

We plan to add text alternatives for all images, amend the colour palette and fix the sequence of headings by August 2025. When we publish new content, we'll make sure our use of images meets accessibility standards.

We are creating an accessibility roadmap to show how and when we plan to improve accessibility on this website. A link to this roadmap will be available in this document by August 2025.

Preparation of this accessibility statement

This statement was prepared on 24th October 2023. It was reviewed on 24th September 2024.

This website was last tested internally on 24th October 2023. This website was last tested externally by Carbon Creative on 24th July 2023.
